A YEAR IN REVIEW Twenty-Five Years and Still Standing ...

The determination, dedication and optimism of a group of young, public-interest lawyers 25-years ago in Rogers Park laid a solid foundation for the Lawyers' Committee for Better Housing to address the housing issues of those **most** in need of legal representation. The founders' hard work and foresight allowed the fledgling organization to weather the storms common to the nonprofit world.

We've made tremendous progress over the past 25 years. Yet circumstances sometimes cause us to question whether we are foolish or optimistic in believing that decent, safe, affordable housing and justice for all can be achieved. We watch with the rest of the world as unpreventable natural disasters expose the preventable disasters present in our communities - **poverty, discrimination and inequality**. The question becomes whether it is more difficult to look at what a disaster like Hurricane Katrina exposes, or not to look. The hope in overcoming destruction is that people will have the courage to look.

Looking into our clients' homes we see a different side of Chicago than most of us imagine. We are proud to call our home Chicago. Still, our client's homes hold a striking resemblance to the homes damaged by natural disasters such as hurricanes and tsunamis. Clearly mold and rat

infestation as well as rotting walls, floors and roofs can just as easily result from landlord neglect.

Chicago may not be fully equipped to cope with the destructive forces of inequality, poverty and discrimination. But, we at LCBH with the support, generosity, and commitment of our tremendous friends and allies have worked to ensure affordable housing is available for all of our community members for the past 25 years, and will continue to fight for as many more necessary until we have won. Thank you to everyone for giving LCBH the opportunity to help Chicagoland tenants find shelter from the storm.

Success in Homesharing

Dr. Alexander, a 79 year old widower sought an individual to share his beautiful, big home in a historic district on the south side. Emily Robinson is a 48 year old Chicago woman who was looking for "affordable housing," though she preferred to find that housing through "community" rather than on her own. By choosing to live in the same house, Dr. Alexander and Emily have both found important needs in their lives met through **HomeSharing**. And their needs have been met through a creative connection ... *gardening*.

Emily could not afford the price Dr. Alexander was asking, but she was able and excited to offer the gift of one of her passions - gardening skills - in exchange for lower rent. Though Dr. Alexander did need extra financial resources, he also wanted someone who could beautify his yard.

HomeSharing made the match worthwhile for both individuals.

Program Highlights

Our three core legal programs provided education, advice, and representation to over 3,720 individuals:

- The **Tenant Advocacy Project** served 148 tenant families, avoiding litigation in 66% of completed cases.

- With the assistance of 30 volunteer attorneys who contributed over 1,000 hours, the **Attorney of the Day Eviction Defense Program** represented 478 low-income families (over 1,500 individuals) in eviction court, achieving success in 78% of the cases.

- The **Affordable Housing Preservation Program** worked with tenant groups in 89 buildings. In addition, 427 tenants were represented in retaliatory evictions, conditions cases or counter claims.

- Our **Case Management** program provided supportive services to 247 of our legal clients, assisting 42 of them in applying for and receiving emergency homeless prevention funds.

- The **Source of Income Discrimination Project** continued to move forward in taking discrimination cases to court and

- Legal staff provided brief service to 1,238 tenants who called for advice and assistance and trained 365 individuals on landlord-tenant law in 30 sessions.

- Our **Housing Policy and Advocacy Program**: Launched the Better Housing Action Network, a project to give tenants the opportunity to make their voice heard on housing issues that impact their lives;

- Our newest project, **Homesharing**, made (INSERT) matches between home seekers and homeowners and continued to serve as an affordable housing solution for Chicago community members.

LCBH Attorneys in action, meant

- A senior citizen was able to remain in her apartment, a full 10 months after eviction proceedings were initiated against her after the turning point when LCBH defeated her landlord's summary judgment motion and successfully postponed trial for an inordinate period of time.

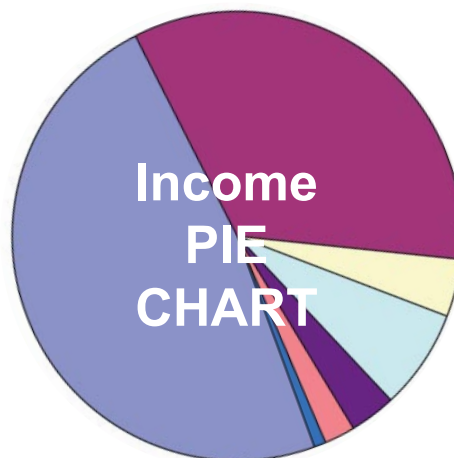
- At trial in another case, a landlord was broken on cross-examination and admitted to shutting off our client's water, as we had alleged.

- During cross examination in the course of a hearing, one landlord that he didn't even own the property, buying our extremely low-income client, who was expecting a baby any day, a month and a half additional time in her apartment, where she remains to date.

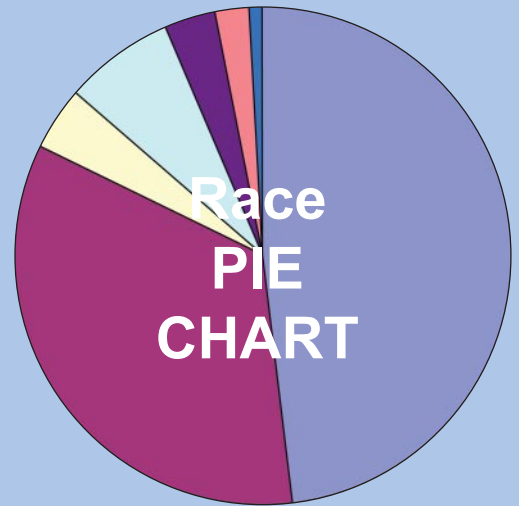

Client Race/Ethnicity

The racial/ethnic breakdown of our clients is:

- African-American, 69%; Hispanic, 15.5%; Caucasian, 15%; and .5% other minorities such as Asian, American Indian, or mixed race.
- The average age of our client head of household is 41, and the average family size is 3.2.
- 30,954 eviction court cases were heard in Cook County during 2005
- The number of forcible entry cases where families are physically removed from their homes and their belongings are left on the street carried out by The Cook County Sheriff's office: Over 6,000.

Client Statistics

An analysis of our 2005 client data base shows that the:

- Median monthly income of our client families was \$1,052 (\$12,624/year)
- Average monthly rent was \$778, which means that these families are paying, on average, 74% of their monthly income toward rent.

While some of these families may have other support such as food stamps not reflected in the income figure, the vast majority of our clients have no housing subsidy. They are simply trying to keep a roof over their heads at a time when unemployment is high and the affordable housing stock in Chicago is shrinking. This unfortunate juxtaposition creates an untenable situation for many of the working poor in Chicago.

AOD Director Gerard O'Toole was involved in his first trial for a client. Our client was a 61-year old disabled woman who, along with her 5 adopted children (ranging in ages from 7-12 years), had moved into a rental house with serious structural defects. She eventually missed one month's rent payment and was sued for eviction. LCBH countersued for breach of warranty of habitability and various RLTO violations, and prevailed on all of our counterclaims, entitling our client to a damages award, which our client declined.

With LCBH representation and settlement efforts:

One 65-year old man was permitted to remain in his SRO apartment, rent free, for 5 months.

A family with 5 children and another child on the way was able to remain in their apartment, rent free, for 4 months.
